#### Payment methods:

## Payment by cash on delivery:

If there is an error or defect in the products or prices in the webshop, we reserve the right to make corrections. The final amount to be paid includes all costs based on the order summary and confirmation letter. User of the Civil Code. 6: 127. §, it is obliged to inspect the package without delay, preferably before delivery to the courier, in case of damage, it is not obliged to accept the package. If the User does not inspect the package, he / she commits a breach of contract and bears the consequences (difficulty in proving the condition of the product).
